Two ends of sighters

Rule 307 Dress regulations: No blue jeans or tops or shirts bearing non-archery related logos.

**(Recurve, Barebow & Longbow shoot on 60cm single face; Compound shoot on 60cm triple face;
all arrows shot in ends of three on Tenzone foam bosses.)**

Entry Fee: £10 per session (Cheques payable to 'Somerset County Archery Association' please.)

Target lists & results sheets will be sent by email unless specifically requested by post & S.A.E.s provided.

Equipment checks will be carried out by the Judges prior to Assembly. Archers are responsible for ensuring their equipment meet the required standards for competition.

N.B. Junior Members shooting must be supervised by a Parent or Guardian at all times.

Assembly Times: Group A: 10.15 a.m. Group B: 2 p.m.

Sighters: Group A: 10.30 a.m. Group B: 2.15 p.m.

Entries for double sessions considered depending on space, but only first round shot for bow style eligible for awards.

Drug Testing: Record Status shoots are liable for drug testing and Competitors approached to give samples must comply; if they refuse, that refusal will be treated as a positive result. Parents/Guardians must sign entries from Junior Archers.

N.B. When you enter competitions the following information may be collected and shared with Tournament Organisers, scoring systems and other competitors: target lists and results may be published with First Name, Surname, Gender, Bow-style, Date of Birth / Age category, Email, Address, Phone number, Club (and ID), County (and ID), Region (and ID), Round (unless defined by age) & Disability info.
